77/06/25. DECLARATIONS OF INTEREST.

78/06/25. PUBLIC PARTICIPATION.

District Cllr Wilton advised that the whole village had been washed with the road sweeper by Wakefield Council.

79/06/25. MINUTES OF THE LAST MEETING.

To consider the minutes of the last Parish Council meeting on Tuesday, 27th May 2025. **IT WAS RESOLVED** that the minutes of the meeting were a true and accurate record and were duly signed by Cllr Wilby J. They were proposed by Cllr Wallis and seconded by Cllr Dunbavin.

80/06/25. ONGOING MATTERS.

- a. To receive an update on the Battery Storage Facility. Harmony Energy are now trying to say that the land is within Grey Belt rather than Green Belt. Heath Residents Association and the Parish Council are going to object. It was resolved that Cllr Dunbavin will draft a letter for the next Parish Council meeting.
- b. To receive an update on the signs for Heath, Kirkthorpe and Warmfield. The Clerk has received the quote for the signs but there is one sign for Warmfield and the No Dogs sign for the play area missing. It was resolved that the Clerk would go back to the sign company and ask for these to be attended to the quote and then send the final quote to the Parish Councillors.
- c. To receive an update on the traffic calming at Kirkthorpe. This is still being monitored. The District Cllrs don't think that a 20mph speed limit through the villages of Kirkthorpe and Heath will be possible. It was resolved that the Clerk will ask the police to attend the Parish Council meeting in September and the District Cllrs will ask for a Highways Officer to attend a Parish Council meeting to discuss this issue.
- d. To receive an update on the bus service through Kirkthorpe. District Cllr Wilton is dealing with this. He has sent several emails but has not yet had a response. It was resolved that District Cllr Wilton will chase this up.
- e. To receive an update on the signage for the footpath up to the Water Tower at Heath. This signage has still not been put up. It was resolved that Cllr Medford will chase this up with Wakefield Council.
- f. To consider speeding through Heath and traffic calming. This has already been dealt with in (c) above.

g. To consider the vacancy for a Parish Councillors. There have been no applications for the Parish Council vacancy as yet. It was resolved that Cllr Wood would go back to the gentleman who had previously enquired to see if he was still interested.

- a. To receive an update on repairs to the Community Centre. No repairs have been carried out.
